JOB CORPS AND SKY WORK CREWS, ALONG WITH VOLUNTEER HELP, PERFORM THE WORK UNDER THE CONTRACTS, THIS HAS MULTIPLE BENEFITS BY PROVIDING NECESSARY TRAIL WORK ON FEDERAL LANDS WHILE ALSO PROVIDING EMPLOYMENT AND TRAINING TO JOB CORPS AND SKY YOUTH. SKY (SERVICE KNOWLEDGE YOUTH) IS A PROGRAM DEVELOPED BY THE PNTA TO PROVIDE AT-RISK STUDENTS WITH AN OUTDOOR-BASED WORK EXPERIENCE BLENDED WITH ACADEMIC AND TRADE INSTRUCTION. MORE THAN 21,000 HOURS OF WORK TOOK PLACE IN TRAIL RELATED PROJECTS.

PNTA IS THE OFFICIAL ORGANIZATION FOR THE DEVELOPMENT AND MAINTENANCE OF THE PACIFIC NORTHWEST NATIONAL SCENIC TRAIL, A 1,200 MILE TRAIL FROM THE CONTINENTAL DIVIDE AT GLACIER NATIONAL PARK, MONTANA TO THE PACIFIC OCEAN AT CAPE ALAVA, WASHINGTON. IT DETERMINES THE ROUTING OF THE TRAIL, OBTAINS RIGHT-OF-WAY AGREEMENTS WITH PRIVATE AND GOVERNMENTAL LAND OWNERS, CONSTRUCTS THE TRAIL OVER NEW OR REROUTED TERRAIN, AND MAINTAINS THE TRAIL ONCE IT IS ESTABLISHED. THE PNTA MAINTAINS A WEB SITE FOR THE TRAIL AND PREPARES MAPS, GUIDEBOOKS AND OTHER INFORMATIONAL PUBLICATIONS FOR USERS ON THE TRAIL.
