PNTA RUNS SKY (SERVICE KNOWLEDGE YOUTH) WORK CREWS, EMPLOYING AND EDUCATING YOUTH FROM UNDER-SERVED COMMUNITIES. SKY CREWS' OUTDOORS-BASED WORK MEETS STANDARDS SET BY STATE AND FEDERAL LAND MANAGERS. PNTA COORDINATES OTHER VOLUNTEER CREWS IN SUPPORT OF AUTHORIZED WORK PLANS ON PUBLIC AND PRIVATE LANDS.
